Why it matters: 2013 grants impacted 36,773 individuals directly and 101,169 indirectly, for a total of **137,942** people impacted.

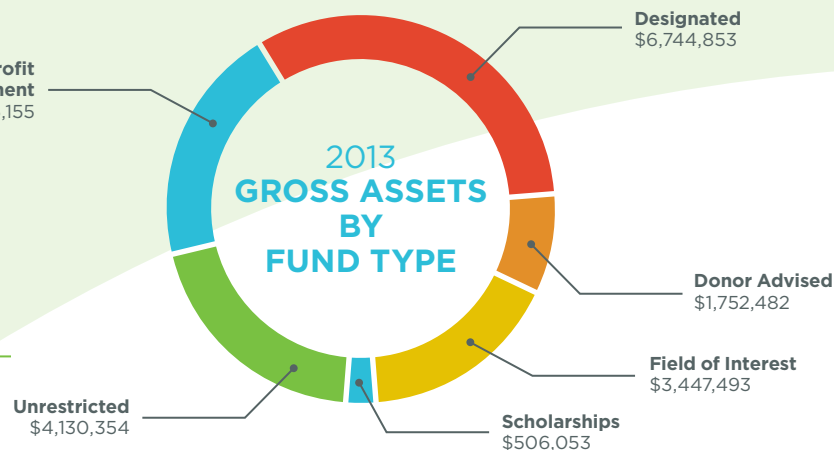

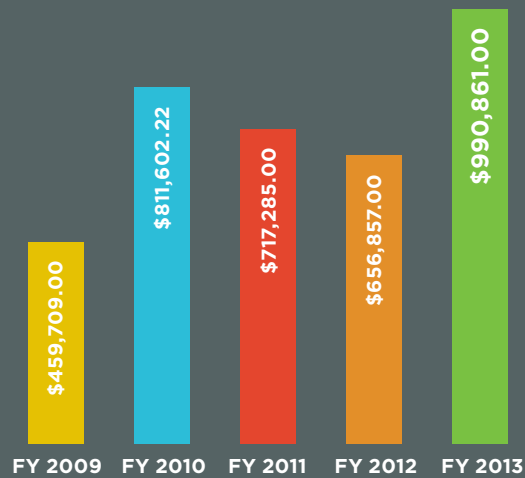

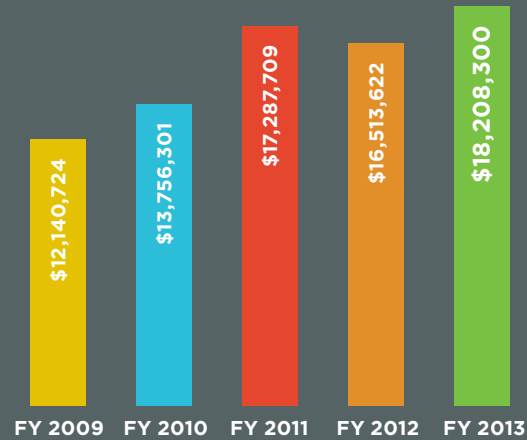
